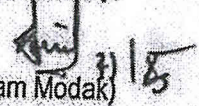
It is to inform you that the National Dental Commission has been constituted w.e.f. 19.03.2026 under the provisions of the National Dental Commission Act, 2023.

Further, as per Section 45 of the NDC Act, 2023, every University and Dental Institution governed under the Act shall maintain a website at all times and display on its website all such information as may be required by the Commission or an Autonomous Board, as the case may be.

Accordingly, all Universities and Dental Institutions are hereby directed to update the following information regularly and ensure that the same is displayed on their websites.

1. Month-wise biometric attendance records of faculty and PG student;
2. Name and contact details of faculty members and PG student;
3. Month-wise total number of Outdoor Patients (OPD).
4. Month-wise total number of Indoor Patients (IPD).
5. Month-wise department-wise details of major clinical procedure being performed including dental implants.
