If yes, give a brief descripiton and a list of modules currently operational (maximum 500 words)	 Management Information System (MIS) is one of the core building blocks essential for strengthening the administration pertaining to various tasks . • Swargiya Dadasaheb Kalmegh Smruti Dental College and Hospital, Nagpur utilizes Management Information System services in the areas related to all the stakeholders. It includes • 1)Student Progression • 2)Certification • 3) Progression and Revenue Generation. Objectives: • To provide information about financial and various operational modules formulated by the Institution. • To help for development of archiving, retrieving, and dissemination of information culture. • To overcome the current challenges of computer auditing for retrieving, converting and translating data from different database schema. • Operational mechanism: Daily report of work done by all the staff can be availed at any point of time by the concerned Incharge and the next in organizational hierarchy. Offline and online mode of MIS include HOD report which has detail description of monthly activities by staff and students .This HOD report is sent to Dean Office at the end of every month and is scrutinized by Dean's office. Any discrepancy/queries related to report is reverted back to respective HOD for the compliances. • The Student information system consists of the details of the students such as the admission details, concession in fees, progression, .atendance, examination scores, special achievements, details of participation of student in various activities. • Institutional Learning Management software was useful for the students as they could attend the lectures at any place in the COVID 19 pandemic. • Daily reporting of Biomedical waste disposal is done through LAN. Solar power generation is recorded on daily basis. • Chairman Local Management Committee is informed regularly about the updates through

proper operational mechanism and reports are submitted for evaluation and assessment of the progress. Reviews of the modules are taken on daily, weekly, monthly basis as per the priority. Interaction, Library, British club, LLM club, READY, DEAR Children, Psychosocial cell, Interns, NEET and Placement cell, Contact cell, AETCOD ,NAAC, Paperless administration, Research, E2, T2 , Dean office review, COVID 19 Protocol and many more are the currently operational modules in the Institute.13 modules have been awarded copyright by Copyright Office, Govt of India. • MIS is utilized at all levels to ensure information is used for evidence based planning and decisionmaking with reforms focusing on rationalizing and standardizing the system and information use mechanisms.

CRITERION I – CURRICULAR ASPECTS

1.1 – Curriculum Planning and Implementation

1.1.1 – Institution has the mechanism for well planned curriculum delivery and documentation. Explain in 500 words

The Institute follows the guidelines of statutory bodies like Dental Council of India (DCI) and strictly follows curriculum of Maharashtra University of Health Sciences (MUHS). CURRICULUM IMPLEMENTATION PLAN: - Curriculum Action plan is approved by College Curriculum Committee of the Institute. The Head of the Department conducts intradepartmental meeting for distribution of curriculum and to discuss the various activities to be conducted during the academic session. Due to COVID-19 Pandemic, the modalities of virtual Teaching and conducting the examination were implemented. All academic activities like lectures, Demonstrations, preclinical practical, Interactions and clinical postings were conducted online on college "NoteMyMail" Platform. The main focus during the teaching was utilizing the online platform to enhance the teaching process. Curriculum is categorized into 3 categories (i.e. MK 60%, DK 30% and NK 10%) and the topics are distributed among the teaching staff as per teaching load for each faculty. The Time table is framed by time table committee depicting Topic, Time, Teacher and Date. Time table for each program was displayed on college Notice Board before the start of session. For implementation of curriculum, various innovative methods like Learning Resources Material (LRM I AND II), Tools (like ICT), Approach (like seminar, group discussion, walk talk & chalk), Techniques, Technology (like 3D digital, simulation, virtual training) are provided. Feedback on curriculum is procured (Refer Metric 1.4.2). AETCOD Module, a value added course, was introduced to inculcate Attitude, Ethics and Communication Skills to learners. (Refer metric 1.3.1). MONITORING PLAN: - Attendance and academic record of learners is maintained by faculty and the report is sent to the Dean by HOD through monthly Report. Mail is sent to the parents of learners with low attendance through HOD and Group Teacher. (Refer Metric 6.5.2). Online Remedial coaching is organized for potential learners under 'Must to Know' (MK) Domain and for rapid learners

under 'Desired to Know' and 'Nice to Know' domain. (Refer Metric 2.5.2).

Emphasis on self-learning as well as peer to peer learning is provided by Demonstrative (Tutorial), Capsulative, Narrative & Reflective teaching. Library is enriched with reference books, text books, e-books, e-journals, DELNET, K-Hub, EBSCO HOST and internet facility (Refer Metric 4.2.2). OUTCOME AND ANALYSIS: - Learners' performance is analyzed through internal assessment examinations, university examinations, project work, presentations, seminars, workshops and skill based programs, which are evaluated through Academic Audit Committee. Continuous evaluation through Cognitive, Formative and Summative examination viz. Three Part Completion Tests, Surprise Tests, Home Assignments, MCQ, University examination etc. (Refer Metric 2.5.2). In order to create competitive environment & to make learners more enthusiastic towards studies, Quiz is organized regularly in Indian Premier League (IPL) way. Details of learners' performance are included in Mentor-Mentee Report which is sent to Dean (Refer Metric 2.3.2) UPDATION OF CURRICULUM: - Thus, entire curriculum implementation procedure encompasses defined focus, clarity, efficient monitoring, interim corrective modality, outcome & transparency which helps in effective curriculum planning, delivery and documentation of curriculum. Higher Statutory bodies like MUHS and DCI are informed regularly about changes and modifications in curriculum.

Feedback Obtained PROCUREMENT: The feedback was collected using the set of questionnaires from the stakeholders (learners, alumni, patients, teachers, professionals, employers and parents) predominantly on curriculum, teaching, infrastructure, research activities, learning resources, governance, library facilities and hostel facility. The curriculum feedback was obtained from the stakeholders in an online manner through standardized forms (Google forms). Feedback on the prescribed parameters was collected from the learners through Student Satisfaction Survey (SSS) (Refer Metric 2.7.1). Feedback on merits and demerits of online teaching was also obtained from the learners. Feedback was collected from alumni about how the curriculum helped them to work in their current employment/education. Teachers, professionals and employers provided their feedback on curriculum. During Parents-Teachers meeting, the feedback was obtained from parents. Feedback on the clinical services of the institute was collected from the patients, by Patients Grievance Committee. The Institution has a proactive `Students Council' constituted of staff and learner representatives. During the monthly meeting (under the chairmanship of Dean), learners provide their feedback on curriculum particularly regarding its execution and other issues. Issues discussed in the meeting which need to be addressed urgently were resolved on priority at Deans level. Psychological analysis and counselling of the learners was done by the Psychiatrist. Feedback on learners psychological analysis was taken from her. ANALYSIS: Analysis of the feedback obtained from different stakeholders was done through a well-set standing mechanism. Responses of the learners received through SSS were analyzed. The feedback on curriculum obtained from various stakeholders was						

Dean, for discussion. UTILIZATION: After the analysis, the data is submitted to Dean, Hon'ble Chairman Local Management Committee and parent body (Swargiya Dadasaheb Kalmegh Smruti Pratishthan), by whom various policies and systems/ procedures are promulgated. At least 85 percent of the data is utilized for these purposes. The feedback is utilized to achieve curriculum development, improvement in academics, research enhancement, improvement in infrastructure and financial management. It is also utilized to improve the Teaching Learning Mechanism, taking it to a higher level with the steady upgrade of the same. The recommendations/suggestions finalized during the discussion in College Curriculum Committee were communicated to Maharashtra University of Health Sciences (MUHS) through proper channel. The Institution has limited role in curriculum revision being affiliated to MUHS and abide by the rules/regulation of the Dental Council of India (DCI). IMPACT: Feedback system ensures the improvement in curriculum, enhancement in Results/ merits (Refer metric 2.6.2) and development of infrastructure (Refer Metric 4.4.1 and 4.4.2). It also aids to attain the financial growth of the institute precisely to mention the corpus fund details submitted to Peer Team in August 2018. It is evident in the steady growth of corpus funds from August 2018 till date. (Refer Metric 6.4.3) The recommendations submitted by the institute to MUHS are considered by university for further appropriate action in terms of modification or restructuring of the curriculum.

Introduction: The institute has developed a modified Mentor: Mentee system. An innovative concept of "Interaction Module" is a brain child of Honourable President Shri Sharadji Kalmegh that was started in year 2006-07. Lot of innovations have been made to make it more effective, wherein the virtual mode of learning through interaction, during the COVID Pandemic was conducted on our institutional LMS. The student mentoring system available in the institution provides a parental touch to the students. It makes teaching-learning effective with intention to formulate and redefine strategies through capacity building of faculty by means of various professional development programs. Also, PBL, CBL, TBL and problem solving methodologies are regularly conducted. This module reflects in the incremental passing percentage of learners and in achieving merits (Refer Metric 2.6.1, 2.6.2). Objectives: • To promote steady academic growth of learners, to make them more competent and confident. • To promote critical reasoning and out-of-box thinking. Operational module: Learners of each year are divided into 5 groups, with one learner being the 'Group Lead'. Faculty member ('Group Teacher') is given responsibility of monitoring academic progress, counselling, mentorship and solving academic or non-academic, personal, psycho-social difficulties of the learners in the group. The mentors contact the parents for academic irregularities, negative behavioural changes, interpersonal relationship issues and other detrimental activities only if required. 'Interaction Module'- a program of Learner-Teacher Interaction helps the teachers understand the differential requirements of newly admitted learners. Institution has started with IPL based guizzes for learners since 2018. To conduct the guiz during interaction, the curriculum is divided into 10 groups. Topics allotted to the groups are considered as home team for IPL based guiz. MCQs preparation and Quiz conduction: The home team prepares MCQs for IPL based Quiz. Each team prepares 100 MCQs on each home topic, creating 1000 MCQs Question Bank on 10 topics. For Quiz competition home team asks 10 questions to other 9 teams consecutively and final round of quiz is conducted amongst the 2 best teams. Monthly reports are generated regarding the Discipline, Regularity and Sincerity of each learner which is a very systematic and reflects the progress of learner. Monthly reports are endorsed along with the comments put forth starting with Group Lead to Group Teacher to the top most level where the comments of next in hierarchy cannot be viewed by the preceding person. There is a monthly review at the level of Honourable President Sir and he annually interacts with the learner's batch wise. Outcome: Passing percentage was improved for Final BDS with 92.5 percent and Final MDS with 100 percent. In BDS Program, Two students secured Gold Medals at affiliated University level and 77 students obtained Honors in different subjects. (Refer metric 2.6.1, 2.6.2). Rapid learners are competent enough to apply for research grants from MUHS and other agencies. With MCQ Bank there is enrichment in Library Resources. Optimization: The systems are prescribed through appropriate policy decisions and are in place to facilitate Teaching Learning. Interaction Module has been copyrighted as part of IPR.

2.5.2 – Reforms initiated on Continuous Internal Evaluation(CIE) system at the institutional level (250 words)

During the learning process, formative assessment is conducted by the institute for the learners as Internal Assessment. After the completion of academic session summative assessment is conducted by the MUHS. This enables quick and overall assessment of learner's performance and difficulties encountered. In 2019-20, a simplified procedure as one-time measure was carried out to conduct pending internal assessment examination for the summer 2020 in view of the prevailing COVID-I9 pandemic. The Online Theory Internal Assessment were scheduled on LMS carried out on NoteMyMail, Online Teaching Platform for easy accessibility to all the learners from any place, where the question papers were shared online on NoteMyMail. Learners wrote the answers, after completion they scanned answer sheets and submitted the PDF file through email to respective in-charge of the examination. Practical internal assessment was also conducted on NoteMyMail online teaching platform. The Teachers Proctored the examination with webcam on of the learners to make the exam system transparent and unfair means in the online mode of examination were avoided. The Examination in-charge submits the answer books of theory/Practical to the respective evaluator of the department and the evaluator prepares the results. Before submission of the result to the Dean office, learners are asked to verify their allotted marks to their satisfaction, if they have any grievances they are sorted out and are resolved by concerned teacher under the supervision of the HOD within stipulated time period. After the lockdown, Learners submitted hard copy of their answer books to the respective department with signature on the answer books. Internal assessment was conducted regularly even during pandemic situation and the result were declared timely. A clear prototype and robust mechanism is used to evaluate the learner's interactive, cognitive and communication skills to enhance their theory, practical, clinical and viva-voce skills. Three sets of question papers are prepared in accordance to the weightage and set pattern with Long answer, Short answer and multiple choice questions as per the guidelines of MUHS, Nashik which are moderated by the designated moderator and are submitted to the Dean, but to make the exam more competitive, there is contingent set of paper based on accruable weightage, degree of difficulty and pattern suggested by the guidelines of MUHS. During contact programs learner is made aware of their performance after every assessment. In the presence of subject teacher, evaluated answer books are distributed to learners to clear their doubts so that they can improve their performance in the further upcoming examination. Records of the assessment are compiled and maintained in individual files for each learner in their respective department. The result is displayed on the notice board, after

signatures of respective students, staff and HOD on the result sheet. Final internal assessment mark list is submitted using online technology to the university by the institute and hard copy in person or post.

2.5.3 – Academic calendar prepared and adhered for conduct of Examination and other related matters (250 words)

Comprehensive academic calendar, which is time bound, is prepared according to the protocols and guidelines of the statutory bodies. It encompasses of academic activities, exam schedule, sports/co-curricular activities, cultural and literary activities which fulfils specified guidelines of the statutory and non-statutory bodies. It meets up to extent of 95 percent and it is adhered for the entire year. When the college academic calendar is prepared, comfort feeling of the learners is given priority for their respective academic session. Monthly operational calendar from commencement till the final evaluation is done and compliance is reported accordingly. Academic calendar includes the onset of academic sessions, conduct of internal assessment and schedule of various events of the institution and affiliating body. During the formulation of the academic calendar, the committee discuss and takes cognizance of important dates and events of university like online rapid revision for all the subjects, state level research competition, Krida Mahotsav and college such as Research competition, Ganesh festival, Cultural activities, Sports Meet. During research competition learners are encouraged to carry out innovative projects which will inculcate creative thinking. Inclusion and utilization of curriculum with accruable weightage and demarcation in Must to know (MK), Desirable to know (DK), Nice to know (NK) is done. (Refer Metric 1.1.1) During the course of learning, learners are informed about the syllabus for each Continuous internal evaluation and procedure. Regular lectures include Innovative teaching modalities like video assisted learning, live demonstrations problem based learning, simulation exercises and integrated teachings. Value added courses are augmented with curriculum to enrich skills and otherwise. (Refer Metric 1.3.1) Three Internal assessment exams are conducted before the final university examination. Record of internal assessment marks are maintained in separate file for each learner. The teachers are made competent by attending various faculty development programs. This helps them to train their learners efficiently and prepare them for examination that gives better outcome. Alternate teaching methods are also conducted such as group discussion, quiz, demonstrations, and laboratory exercises and integrated teachings. After completion of prescribed syllabus for lectures, clinical assessment, and revision session are conducted, it is followed by periodic formative assessment. In order to have holistic feedback, parents are regularly oriented during the Parents Teacher meetings on the curriculum, regarding timely conduction of Continuous internal examination and requirements of the course to obtain their valuable inputs on the same. Action plan for internal assessment is recommended by in-charge of academic, examination committee and under graduate /Post graduate (UG/PG) director and then finally Dean issues the circulars. (Refer Metric 1.4.2). The prepared calendar is displayed on the notice board and college website. The end users i.e. the learners were satisfied with the transparency in the conduction of examination and evaluation procedure, which was evident by the SSS.

5.3.2 – Activity of Student Council & amp; representation of students on academic & amp; administrative bodies/committees of the institution (maximum 500 words)

As per the guidelines of MUHS the institution has a proactive Students Council which comprises of teaching faculty and student representatives. Specific mechanism for the constitution of the student council as per the guidelines of MUHS, is followed. Information of various sub- committees which include Alumni, Student Patient Welfare, Student wellness, Library, Sports, Cultural, Hostel, Literary clubs in order to achieve effective and smooth functioning of the council was provided. Objectives: ? To encourage participation of students in activities which facilitate in developing various skills and competencies and the holistic development. ? Our Institute provides necessary support to the council members in organizing and coordinating various activities (academic, co-curricular and extracurricular) throughout the year. The annual sports and cultural events for the year 2019-2020, (Vakratunda, and graduation ceremony (Udaan) were planned and conducted by student's council in

coordination with class representatives. Funding of cultural events were shouldered by the institute. ? Two practices of decentralization and participative management that Institute follows are: 1) Departmental progress Evaluation and Review: Institution has a unique system of academic and administrative progress evaluation of the departments. It is done with a predesigned proforma, wherein all the activities to be evaluated are incorporated. The committee headed by Dean reviews the performance along with the supporting documents submitted by respective HODs biannually. Corrective measures are suggested for improvement of the performance and in turn Action Taken Report is generated. Growth projection is formulated on the basis of the data and is submitted for evaluation. Total HOD fund disbursed for the year 2019 - 2020 was 75 Lakh which is given to all dental, medical, IT and MM Departments. Audit committee gives specific instructions with regards to fulfillment of shortcomings which results in the upliftment of department pertaining to academic, administrative and infrastructural parameters. 2) Research participative management: The Institute has amended its research policy and overall structure of its committee to have better outcomes. The current structure of Research Committee comprises of 4 staff members. Two members of committee look after research of Undergraduate students and Staff, while other two scrutinize PG progress and their associated research work. There are specific reporting proformas from Part A to E to be filled at departmental level and subsequently submitted to Research Committee on monthly basis. The Committee then evaluates all parameters and draws conclusion which is then discussed with the Dean. A review is scheduled with higher authorities once in fortnight for assessment of progress. Feedback is obtained from Students, faculty and other stakeholders along with their suggestions. The inputs given are incorporated and forwarded to HODs for implementation. The Research policy was also amended with inclusions of many critical aspects of research viz. Best Practices -1 1. Title of the Practice: Telephonic Medical and Psychiatric Examination(T2) Module 2. Objectives of the Practice • To evaluate the physical			

Examination(T2) Module 2. Objectives of the Practice • To evaluate the physical and mental fitness of the staff. • To ensure good health and keep the staff safe against the physical and mental stress caused due to Covid-19. 3. The Context: During the difficult times of Covid-19 pandemic, it becomes important to maintain good physical health and mental health as well in times of lockdown and isolation. At Swargiya Dadasaheb Kalmegh Smruti Dental College and Hospital, we are particular about maintaining both during these tough times and hence, a module namely Tele - Medical as well as Tele - Psychiatric check-up for the Teaching and Non-Teaching staff was formulated to disseminate knowledge on health issues. 4. The Practice: a. The Tele-Medical check-up was conducted by very experienced medical officers of the Institutional Hospital and included doctors were MD Medicine, Gynaecologist and a General surgeon. b. The Teaching, Non-teaching and the Contractual staff were allocated a particular time, Department wise for medical and psychiatric examination. c. Several relevant questions related to medical health were asked by the Doctors to find out whether the concerned staff was physically fit, or else some intervention would be required. d. For Psychiatric evaluation, we outsourced and hired a wellknown Psychiatrist of repute, who did the Tele-Psychiatric evaluation, and also by video conferencing. Very systematic and intelligently framed questions were asked to get an insight on the mental wellbeing of the staff. e. A recording of the consultation was also done for future reference. f. A designated fund to the tune of 1 lakh was set aside for the said purpose. 5. Evidence of Success: a. In this time of the Covid Pandemic where it is seen creating lot of stress and uncertainty in the world, the staff at our Institute were found to have a high morale, which was further boosted by the knowledge that the Institute cares for their wellbeing. b. Apart from the Medical care, it was a great opportunity for the staff to open up and overcome with any kind of psychological stress that they were going through with full confidentiality and also the knowledge that they were in very safe hands. c. The medical and psychiatric evaluation gave the staff an assurance about their physical and mental wellbeing and they did not feel the stress while attending their routine duties and also performed to the optimum level. d. Very few cases of Covid- 19 positive were reported and as per the protocol, they were quarantined and precautions were taken to prevent and restrict further spread of the infection. 5. Thus, overall number of infected cases were restricted effectively. 6.

Problems Encountered and Resources Required a. In spite of regular awareness campaigns from college regarding screening of Covid-19 some Non- Teaching Staff did not come forward to report or to get diagnosed for Covid-19, may be due to

fear of getting isolated or the spread of said disease. b. Human, infrastructure and financial resources have taken a first step in successful implementation of the module c. As the recording of the sessions were done, it has been made possible to keep these records for future reference, thus enabling accountability. Best Practices -2 1. Title of the Practice: Structured Module of Contact Cell 2. Objectives of the Practice a) To increase OPD patients. b) To evaluate proper treatment availed by the patient. c) To assess patient satisfaction regarding oral health care. 3. The Context: The contact cell module basically works on the patient dentist relationship. This helps us to build good rapport with patients and at the same time helpful in solving grievances, if any. In contact cell module patients are contacted for their treatment, follow up and review. This helps in successful completion and follow up of the treatment rendered. In case of scheduling and rescheduling of appointments, it is proved to be beneficial. It is also helpful in resolving queries of the patients, if any. All the departments are maintaining the updated data in contact cell register. This has to be done periodically. There is quarterly, half yearly and yearly review of records in each department by respective in charges. 4. The Practice: The contact cell has been developed to maintain data of all patients reported to the institute. This data is being utilized by the department for follow up wellbeing of patient and good patient rapport. After resolving the chief complaint, patients neglect their remaining treatment which is also of vital importance. To overcome this, reminding the patient has benefitted by virtue of the contact cell. a. The Cell has been constituted with active participation of all the Staff members from all the departments. b. Individual patients are contacted and are asked to visit the institute for the treatment and follow up. c. Contact cell register is maintained in the respective department. d. Regular follow up and feedback is taken from the patients regarding patients' satisfaction. A positive association has been established between patient's satisfaction and the care they receive. This lead to the willingness to communicate and empathize with patients. Open dialogue with patients resulted in better patient retention and a reduction in complaints. Contact cell is very helpful in maintaining patient's appointments. It has been observed that at times patients miss their appointments due to certain reasons, therefore to send them reminder and to complete their remaining treatment, this contact cell module is proving very helpful. 5. Evidence of Success The contact cell module has helped us to keep periodic communication with the patients, during and even after the completion of treatment. More than 12000 patients were telephonically contacted in this year. With this means patients are called for follow up which helps in increase in OPD patients. It also helps in providing quality and complete treatment to the patients. The record of patient's data is maintained in every department. 6. Problems Encountered and Resources Required There are limitations in follow up of the patients. However, the percentage of responded persons is reasonable. Eventual dropout rate is around 10 percent, due to circumstantial reasons including migration on account of jobs, education, livelihoods etc. This module has been copyrighted as the part of IPR in the current year.

Institutional Distinctiveness ANNAPURNA SCHEME- The name Annapurna is a mark of respect and tribute to Smt. Pramilatai Dadasaheb Kalmegh, widow of Swargiya Dadasaheb Kalmegh who is popularly distinguished and known as 'Annapurna' throughout Vidharbha. Her determination, contribution and diversified actions has played a major role to stand as a robust pillar with Dadasaheb Kalmegh. No one went hungry from her place and this was noticed as mentioned in the Biography of Dadasaheb Kalmegh authored by Mr. V. V. Chaukhande. There are regular budgetary provisions allocated for providing food by the Institution, but whenever it exceeds, extra provision is made by Hon'ble President Sir from his personal savings. India accords high priority to the issue of hunger and malnutrition and the Government implements several schemes to improve food situation in the country. At Swargiya Dadasaheb Kalmegh Smruti Dental College and Hospital, it is noticed that, there are many people who come from far-flung rural areas to visit Dental Hospital for treatment. They could scarcely afford lodging and often have to struggle for food. These people are mainly farmers or daily wage labourers, and they have additional burden of travelling to and from the hospital. The effort to serve these masses, keeping the traditional value of providing food and service to humanity is continued regularly in our

Institution. The college provides free food at the college canteen for poor, needy underprivileged patients and their relatives who come from distant remote places, for treatment and more than 1800 persons have been benefitted from this effort during this year. Volunteers identify the poor and needy people and food is served to them in canteen. During the outreach activities also, free food packets are provided to all the needy patients. Snacks are provided oftenly to the students sitting for late hours in the library. Blood donation camps are organized in the Institute on the occasion of Birth anniversary of Late Shri Dadasaheb Kalmegh, where all the blood donors are provided with refreshments and Free meals. This year also, a medical dental diagnostic treatment camp was organized at Sai Mandir, Nagpur, wherein free Lunch was provided to all Patients devotees. Orphans, physically handicapped and poor patients are also provided with refreshments and free meals. The Department of Pediatrics and Preventive Dentistry under their banner DEAR-children has adopted 21 Schools for their Extension activities and Services. Similarly, the institute has also adopted 15 Villages under the banner READY (Rural Education and Awareness of Dentistry Yojana). The institute looks after the overall dental healthcare needs at affordable cost or sometimes free and also provides refreshments and Free meals rich in nutrition for the needy visiting the campus.
